**4.1.6 Eligibility**

In order to be eligible to be a state delegate the candidate must be a registered Republican continuously for the two years preceding their election as a state delegate, age permitting, and either:

- A. Attended 25% or more of the party's meetings in the calendar year preceding the election as a delegate, in the past year (effective the date of adoption), or
- B. Served diligently on a RPCC committee for a year prior.
